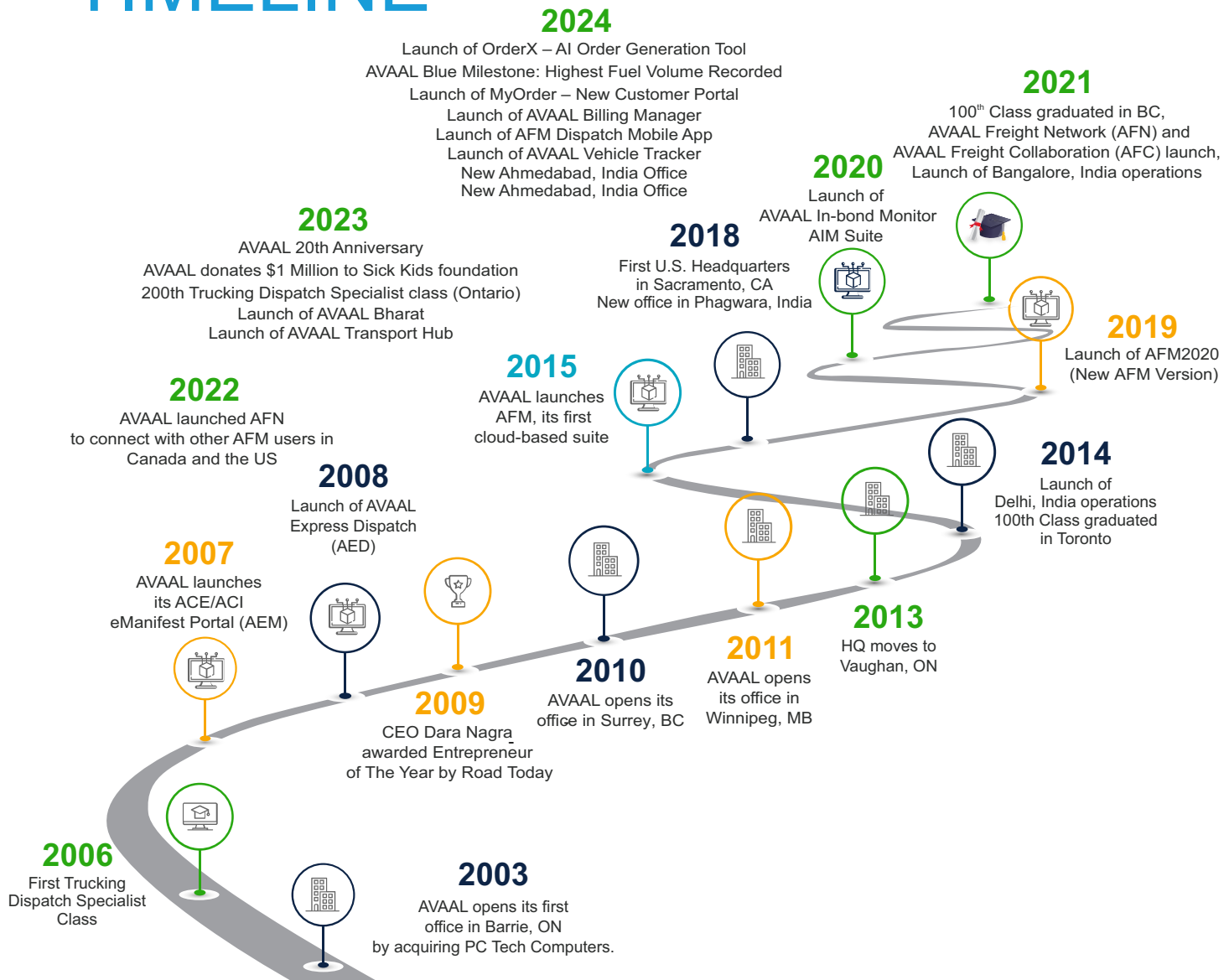

IFTA, NY, NM, KY, & OR TAX FILING

The International Fuel Tax Agreement requires quarterly fuel tax return filings for all carriers. The above US states collect Highway Use Taxes that also require quarterly filing. Let AVAAL take care of the tedious number crunching.

USA AND CANADA CUSTOMS BONDS

Improve the scope and flexibility of your business as a Bonded Carrier. Canada and USA Bonded carrier status allows you to move goods inland to a customs office in the respective country to be later released by customs, or to move goods through Canada or the USA while enroute between two points in the other country. A bonded carrier posts security with the Canada Border Services Agency to cover the following:

- ✓ To move goods to an inland CBSA office in order to have the shipment released.
- ✓ To apply to the Post-Audit Program.
- ✓ To move goods "in transit" through Canada.
- ✓ To apply to the Customs Self Assessment Program and/or the Free and Secure Trade (FAST) Program.

FREIGHT BROKER/FORWARDER BONDS

The Freight Broker/Forwarder Bond or BMC-84 surety bond is a license surety bond required by the Federal Motor Carrier Safety Administration (FMCSA) in the amount of \$75,000. This surety bond is required by all freight brokers operating in the United States.

The Free and Secure Trade (FAST) program is a commercial clearance program designed to ensure safety and security while expediting legitimate trade across the Canada-United States border.

- ✓ Reduces delivery times and landed costs of imports.

- ✓ Increases certainty at the border, resulting in fewer delays.
- ✓ Can be used as proof of identity (US and Canadian citizens).



The Customs-Trade Partnership Against Terrorism (C-TPAT) is a voluntary partnership between Customs and Border Protection (CBP) and the international trade community to secure the international supply chain.

Partners in Protection (PIP) is a Canada Border Services Agency (CBSA) program that enlists the cooperation of private industry to enhance border and trade chain security, combat organized crime and terrorism, and help detect and prevent contraband smuggling.

- ✓ Reduced Automated Targeting System (ATS) scoring, for less frequent inspections.

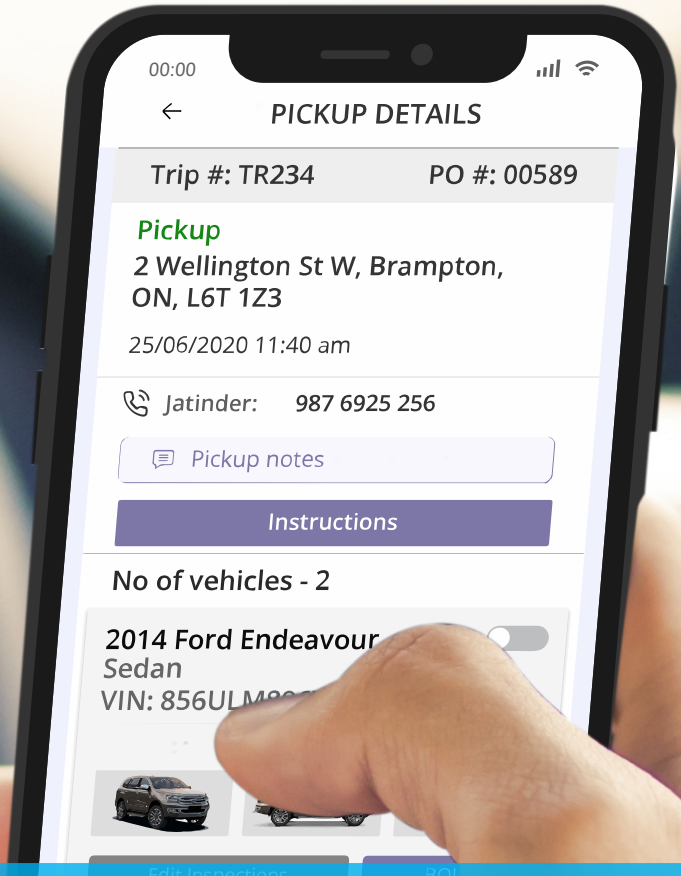
